什么是 RoHS 2.0

在2015年6月4日，欧盟发布了修订指令 (EU) 2015/863，修订ROH2.0指令2011/65/EU，将DEHP,DBP,BBP,DIBP这四种邻苯二甲酸酯列为限制使用物质进行管控，ROHS 2.0 中的限值物质增加到10种。2019年7月22日起，除医疗设备和监控设备以外的所有电子电气设备都必须满足ROHS2.0的新要求。



On June 4th 2015, the European Union issued the revised directive (EU) 2015/863, revised the ROH2.0 directive 2011/65/EU, and listed the four phthalates of DEHP , DBP , BBP and DIBP as Limit the use of substances for control , the limit substances in ROHS 2.0 increased to 10 kinds . From July 22th , 2019 , all electrical and electronic equipment except medical equipment and monitoring equipment must meet the new requirements of ROHS2.0.

Electrical and electronic products and their raw materials (including but not limit to: large household appliances,small household appliances , information technology and communication equipment , consumer equipment , lighting equipment , electrical and electronic tools,toys,leisure and sports equipment,medical equipment,monitoring equipment,vending Equipment,other electrical and electronic equipment).
